NOTES:

1. PRODUCER/TRADER/MARKET OWNER: Initial and Annual Fee cover cost of initial and annual reinspection to a ceiling of 3 hours for inspection and \$200 for travel costs and travel time. Additional inspection hours will be charged at \$110/hour. (Quotation in advance supplied on request)
2. SMALL PRODUCER: Initial and Annual Fee covers cost of initial and annual reinspection to a ceiling of 2 hours for inspection and \$200 for travel costs and travel time. Additional inspection hours will be charged at \$110/hour. (Quotation in advance supplied on request)
3. PROCESSOR: Deposit may be greater if operation remote and/or complex. Post inspection balance includes assessment and tests if required.
4. INPUT MANUFACTURER: Reinspection, initially on annual basis, may be increased to every 2-3 years subject to NASAA assessment.
5. INTERNATIONAL: Inspection Deposit includes all travel overheads, AUD\$850/day for estimated number of inspection days + AUD\$450/day for estimated number of travel and report-writing days. Post Inspection fee includes any tests required, NASAA review fee based on AUD\$120/hour and any adjustments for travel, inspection and report-writing. Reduced inspection day rate of \$550 applies if inspector is resident in the country of the operator.
6. SUBLICENCE: Where an operator is licensed to use the services of a non-certified third party.
7. MULTIPLE LOCATION: Where an operator has licences at more than one location which are all in the same operator name.
8. TRANSFERS: Fees as per relevant category apply.
9. Additional fees apply for fast tracking, new acreage, new products and testing.

NOTES AND PAYMENT TERMS:

1. Strictly 30 days unless otherwise stated on invoice.
2. Application Fees, Annual Fees and Levy Payments are non refundable.
3. Advance payments or deposits for inspections are generally refundable if application is cancelled prior to inspection.
4. Pro rata portion of Annual Fee is charged in first year of licensing for label use.
5. Annual Fee is payable in full on 1 July.
6. Levy, if payable, is charged in full on 1 January on organic sales made in the previous calendar year.
7. Previous quarterly payment option for Annual Fee and Levy applies only to existing operators. Quarterly Terms:
 - Non-refundable Admin Fee of \$66 payable with first quarter fees;
 - Option to pay quarterly not available unless it is exercised by 31 July or paid by 28 August, which is an absolute deadline;
 - Penalty Fee (\$44) applies if quarterly payment of Annual Fee or quarterly Declaration not made and paid by due date;
